LION ROARING PRIVATE MEMBERS ARTICLES OF AGREEMENT

Founded August 2023 (updated May 30, 2025)



Article I - Name, Base of Operations, Purpose

Section 1. The official name of this Private Members Agreement shall be Lion Roaring Private Members Agreement (known as the Agreement or PMA - Lion Roaring, PMA)

Section 2. Lion Roaring, PMA is based on or near Germantown, Maryland.

Section 3. The purpose of Lion Roaring, PMA to fulfill the God given call to the founding Member(s) to take dominion over the land; air and water as divinely created for and commanded to in Genesis 1:26-28. 26. Furthermore God said, "Let us make man in our image according to our likeness, and let them rule over the fish of the sea, and over the fowl of the heaven, and over the beasts, and over all the earth, and over everything that creepeth and moveth on the earth. 27. Thus God created the man in his image: in the image of God created he him; he created them male and female. 28. And God blessed them, and said to them, Bring forth fruit, and multiply, and fill the earth, and subdue it, and rule over the fish of the sea, and over the fowl of the heaven, and over every beast that moveth upon the earth.

We will fulfill the desire of our hearts as promised in Psalms 37:4 And delight thyself in the Lord, and he shall give thee thine heart's desire. We will answer this call from God to inspire others to grow while growing ourselves and to live and work according to 2 Corinthians 3:2 Ye are our epistle, written in our hearts, which is understood and read of all men to have Gods word written in our hearts; to be known and read by all (wo)men whom we serve. We answer this call to run our race according to 1 Corinthians 9:24 Knew ye not, that they which run in a race, run all, yet one receiveth the prize? So run that ye may obtain. We press on in our daily actions toward the goal as expressed in Philippians 3:14. And follow hard toward the mark, for the prize of the high calling of God in Christ Jesus. Our belief is in Hebrews 13:21 Make you perfect in all good works, to do his will, working in you that which is pleasant in his sight through Jesus Christ, to whom be praise forever and ever Amen. God has equipped us in every good work to fulfill this calling. We commit that in all our hands find to do, we will do it with all our might as commanded in Ecclesiastes 9:10. All that thine hand shall find to do, do it with all thy power for there is neither work nor

invention nor knowledge, nor wisdom in the grave whither though goest. As per Genesis 1 1. In the beginning God created the heaven and the earth. 2. And the earth was without form and void, and darkness was upon the deep, and the Spirit of God moved upon the waters. 3. Then God said, "Let there be light: And there was light." And throughout the remainder of Genesis 1 God creates the heavens, the earth, and all that walk, fly and swim as well as man and woman. God then through His words commanded man and woman to take dominion over the land, air and water. As God spoke creation into existence with His words so we the Founders and Trustees of Lion Roaring, PMA speak and express with our words the creation of Lion Roaring, PMA. That which one creates one controls. God said:" To travel the pathways of life, it is necessary to know beforehand the path that your conscience outlines, whose spiritual law proceeds (earning) from the Divine Spirit." God has given the path of Lion Roaring to create a habitation where Supernatural and solution intersects by bringing heavenly culture and attributes on earth through our freedom which is the free will of our soul that God has given to us.

Section 4. This Lion Roaring Private Members Agreement hereby declares that our objective is to maintain, improve and protect our basic human rights, constitutional guarantees and political freedom as well as nurture, support and strengthen our relationship with God for every Member Worker, National, Breathing and Living Man or Woman of these united States of America and that our rights to form this Private Members Agreement are granted among other things, by the Creator and second, by the united States Constitution, by the Maryland Constitution and by Common Law. This objective also pertains to all law-abiding people of other countries from around the world whose constitutional provisions and faith in God embrace similar rights, freedoms and beliefs as those in these united States of America.

Section 5. This Lion Roaring Private Members Agreement, stands on the Maryland Constitution last amended and ratified by the voters on November 3, 2020. We stand on the Maryland Constitution Declaration of Rights, more specifically Article 1. That all Government of right originates from the People, is founded in compact only, and instituted solely for the good of the whole; and they have at all times, the inalienable right to alter, reform or abolish their Form of Government in such manner as they may deem expedient. We stand on Article 2. The Constitution of the United States, and the Laws made, or which shall be made, in pursuance thereof, and all Treaties made, or which shall be made, under the authority of the United States, are, and shall be the Supreme Law of the State; and the Judges of this State, and all the People of this State, are and shall be bound thereby; We stand on Article 6. That all persons invested with the Legislative or Executive powers of Government are the Trustees of the Public, and, as such, accountable for their conduct: Wherefore, whenever the ends of Government are perverted, and the public liberty manifestly endangered, and all other means of redress are ineffectual, the People may, and of right ought, to reform the old, or establish a new Government; the doctrine of nonresistance against arbitrary power and oppression is absurd, slavish and destructive of the good and happiness of mankind. We stand on Article

10. That freedom of speech and debate, or proceedings in the Legislature, ought not to be impeached in any Court of Judicature. We stand on Article 24. That no man ought to be taken or imprisoned or disseized of his freehold, liberties or privileges, or outlawed, or exiled, or, in any manner, destroyed, or deprived of his life, liberty or property, but by the judgment of his peers, or by the Law of the land. We stand on Article 26. That all warrants, without oath or affirmation, to search suspected places, or to seize any person or property, are grievous and oppressive; and all general warrants to search suspected places, or to apprehend suspected persons, without naming or describing the place, or the person in special, are illegal, and ought not to be granted. We stand on Article 36. That as it is the duty of every man to worship God in such manner as he thinks most acceptable to Him, all persons are equally entitled to protection in their religious liberty; wherefore, no person ought by any law to be molested in his person or estate, on account of his religious persuasion, or profession, or for his religious practice We stand on Article 40. That the liberty of the press ought to be inviolably preserved; that every citizen of the State ought to be allowed to speak, write and publish his sentiments on all subjects, being responsible for the abuse of that privilege. We stand on Article 45. This enumeration of Rights shall not be construed to impair of deny others retained by the People.

All in line with the constitution of these united States of America and the Constitution of The united States of America. This Private Members Agreement is in the private. Lion Roaring PMA members claim their constitutional rights to meet in the private, their freedom of religion, speech and press, our freedoms from searches and seizures and the right to be secure in our persons, houses, papers and effects, to freely assemble together to counsel for the common good, to make known our opinions, and to have the right to privately contract with one another without interference from local, county, state, LOCAL, COUNTY, STATE or FEDERAL interference and to have the freedom to include any people into our Private Members Agreement.

Section 6. This Private Members Agreement stands on the freedoms as expressed in the Universal Declaration of Human Rights proclaimed by the United Nations General Assembly in 1948. The declaration created a common standard of achievements for all peoples and all nations recognizing fundamental human rights. This standard of achievements has been translated in over 500 languages with the intent to recognize the unalienable human rights. We stand on Article 1. All human beings are born free and equal in dignity and rights. We stand on Article 2. Everyone is entitled to all the rights and freedoms set forth in this Declaration. We stand on Article 3. Everyone has the right to life, liberty, and security of person. We stand on Article 17. Everyone has the right to own property alone as well as in Agreement with others. Black's Law Dictionary describes property as That which is peculiar or proper to any person; that which belongs exclusively to one; in the strict legal sense, an aggregate of rights which are guaranteed and protected by the government. We stand on Article 18. Everyone has the right to freedom of thought, conscience, and religion. We stand on Article 19. Everyone has the right to freedom of opinion and expression; this right

includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers. We accept that media may include session, coaching, healing techniques, midwifery care, health services, blood infusions, massage, acupuncture and needling, health and wellness coaching, herbal products and usage, naturopathy, and various other energetic ad nature-based media. We stand on Article 20. Everyone has the right to freedom of peaceful assembly and Agreement. And we stand on Article 23. Everyone has the right to work, to free choice of employment and favorable remuneration ensuring for himself and his family an existence worthy of human dignity.

Section 7. We believe that the First Amendment to the Constitution: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press, or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.; guarantees our members many rights including but not limited to the right to associate in private, the right to free speech, the right to free press, the right to assemble and the right to worship God, the right to share the Gospel, the right to encourage one another with biblical love. The right to meet together according to Matthew 18:20 For where two or three are gathered together in my Name, there am I in the midst of them. We believe this includes the right to gather for the lawful purpose of advising, helping, providing goods and services, and serving one another in our rights in any field of human or Godly interest, per the Federal and State Constitutions and common law as well as following God's law. We believe and stand on the Second Amendment -A Well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed. We believe the 4th Amendment of the Constitution of the united States of America: The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.; secures our right of privacy and protection of our persons, houses, papers and effects against searches and seizures, we believe the enumeration of certain rights shall not be construed to deny or disparage others retained by our members per Amendment IX; The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.; and we retain the right to privately contract per Article I Section 9. No Bill of Attainder or ex post facto Law shall be passed. And Section 10 of the Constitution of the united States of America.; and Section 10. No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make anything but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility. We therefore stand on silver minted coin to contract with one another, which no government or state can impair.

Section 7.1. We believe that each man and woman is responsible for his or her own beliefs and that any information, products, services, or advice they receive it is up to them in their divine sovereignty to discern the truth for their own peace of mind. Each man and woman in their sovereignty is responsible for any decisions made to receive, participate, ingest, or receive any goods, services, trainings, coaching, sessions or counsel from other Members of the Lion Roaring PMA and take full responsibility for such decisions. All Members agree to remain in the private with other Members and to never enlist outside litigation, civil courts, or other legal actions outside of the Lion Roaring PMA.

Section 7.2. We believe in the right to privately contract with one another as sovereign men and women, creations of Nature and Natures' God. We believe that according to the Federal Constitution Article I Section 9 stating: The Privilege of Writ of Habeas Corpus shall not be suspended, unless when in Cases of Rebellion or Invasion the public Safety may require it. No Bill of Attainder or ex post facto Law shall be passed, defend, promote, and protect this right to privately contract with one another.

Section 8. We declare our rights under the amendments to the Constitution of these united States to gather, worship, and operate our Agreement in the Private Jurisdiction and Domain, as guaranteed by the 1st -Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press, or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. As guaranteed by the 2nd A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed. As guaranteed by the 4thThe right of the people to be secure in their persons, houses, papers, and effects against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized. As guaranteed by the 9th The enumeration in the Constitution of certain rights, shall not be construed to deny or disparage others retained by the people. As guaranteed by the 10th, The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people. We claim these unalienable rights given in these Amendments of the united States Constitution as well as to claim dominion over water, air and land as commanded by God in Genesis 1:28. "And God Blessed them, and God said to them, Bring forth fruit, and multiply and fill the earth, and subdue it, and rule over the fish of the sea, and over the fowl of the heaven, and over every beast that moveth upon the earth". All Agreement activities are limited to our Private Agreement Members and are in the private domain only.

Section 9. We establish this PMA on the land that is generally considered to be Maryland State, an independent state of the Nation style by these united States of America, without the United States

Washington D.C. corporation. The PMA is not part of, nor does it associate in any way with THE STATE OF MARYLAND, a private for-profit corporation, denoted with a Dun and Bradstreet number #847612442.

Section 10. The founder(s) of Lion Roaring Private Members Agreement declare and believe that God's Holy Word, the Bible, is the ultimate Law of the Land and the ruling law of We the People and that the Bible, God's Holy Word is recognized as the supreme law of the land of all local, county, state, federal and LOCAL, COUNTY, STATE AND FEDERAL laws as recognized by the 97th Congress Joint Resolution; Public Law 97-280 – October 4, 1982

Section 11. The founder(s) of Lion Roaring Private Members Agreement declare the right to select a spokesperson from our Members who we believe able to provide Members with the highest quality support to maximize their freedoms, rights as living men and women, to successfully build their own private Agreements, to incorporate successful business practices in all Agreements or businesses our private Members create, to create innovative centers and education centers, to provide holistic healing with modern technology, to provide training, nutrition, shelter, and other resources to provide for the holistic healing, wellness, nurturing and supportive environment to men and women.

Section 12: We establish this Lion Roaring PMA's products and services based on the 1st Amendment of the united States Constitution "congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

The Lion Roaring PMA provides products and services to include but are not limited to:

- 5. Lion Roaring Foundation

 - c. Training and mentorships in all areas of Lion Roaring
 - d. Restoration of cities and states via education
 - e. Private Banking and Trusts
- 6. Music, Media Innovation Center
 - a. Music, Worship and Arts training and support
 - b. Harp, Shofar and other Instrument training and support

John 7:38 said" He that believeth on me, as the scripture hath said, out of his belly shall flow rivers of living water. " (KJV) and James 2:26: "For as the body without the spirit is dead, so faith without works is dead also." (KJV)

God is the living water that signifies the living wisdom out of heaven. His Word is the living faith, the faith coupled with love. It is not an isolated faith but an active faith requiring deed as faith without deed is dead. Jesus said: "Nobody will reach the light through faith alone, but only through the deed according to My Word!"

Through John 7:38, Lion Roaring Education Center (LREC) will provide education and humanitarian projects in order to obey and act according to His eternal love. Currently, LREC will focus on seven areas below but is not limited to the following:

- 1. Child & Drug abuse Our focus is to protect children from any form of maltreatment which means any form of ill or inhumane treatment,or neglect. We will provide collaborative intervention services to child abuse victims. Drug abuse can lead to physical and mental damage and dependence and addiction, leading to mind-altering effects. Drug abuse hampers a person's power to practice self-control and interferes with their ability to resist the urge to take drugs. Our focus is to provide education and counseling, seeking help from parents and peers, offering affordable professional and medical services.
- 2. Wellness Health Care Our focus is the wellness and healthcare of underprivileged people in remote areas, broken communities, villages, and cities. Training and equipping local practitioners by reaching out and assisting them to practice healthy habits (physical, emotional, intellectual, social, spiritual, environmental and occupational) on a daily basis will ensure better physical and mental health outcomes.
- 3. Famine & Malnutrition Our focus is to prevent hunger and malnutrition by providing food and by promoting farming methods for sustainability for a hunger free community. We will provide education, nutrition advice livelihood resilience, and institute social protection systems such as school meal programs.
- 4. Orphanage Our focus is to feed, clothe, shelter, and educate children by raising them in the Lion Roaring habitation and by training them through the Seven Lion Roaring community of interest group.
- 5. Homelessness Our focus is to see individuals and families set free from addictions and homelessness, and to be transformed by God to become physically and spiritually healthy along with education through the Lion Roaring community of interest groups.
- 6. Single Parents Our focus is to empower single parents to lead successful families and educate them, thus assuring strong communities through Lion Roaring habitation.
- 7. Prison Lighter Our focus is to restore those affected by Crime & Incarceration through supernatural transformation and to become physically and spiritually healthy. Education will follow to help them re-enterenter society through the Lion Roaring Community of interest group.

In addition, in our homebase, Lion Roaring provides Maryland and surrounding state products

Lion Roaring Private Members Agreement's (PMA) focus is to bring Heaven's cultures on earth and to restore nations (communities, cities, states, and countries) through each soul whom the Lord has transformed and chosen. This soul will be given the opportunity to work for the Lion Roaring Innovation Centers and its partners being fully educated through Lion Roaring Foundation as God's king and priest. The goal for each soul is to create inspired ideas and become self-sufficient to perform good works and bring heaven's attributes into its environment.

Section 13. We declare the freedom to house animals, engage in husbandry, and provide farm products in the private, to educate, counsel, support and train people in various life skills and arts, to utilize wellness and holistic techniques and strategies, and to exercise our freedoms to associate, participate, contract with one another and serve one another exempt from any local, county, state, federal, LOCAL, COUNTY, STATE or FEDERAL statutes, codes, regulations or rules

Section 14. Adopting 1st Amendment of the united States Constitution "congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.", it is expressly declared that the Lion Roaring Private Members Agreement, which is not a public corporation, profitable business partnership, company, estate, joint stock Limited Liability Corporation, nor trust, nor any other form of publicly incorporated Agreement, is hereby created as a separate, lawful, spiritual, private unincorporated entity. No local, state, county, federal or LOCAL, STATE, COUNTY OR FEDERAL regulating body, entity, committee, organization or other such group has any lawful jurisdiction over this Private Members Agreement. Any disputes will be handled and determined within the Private Members Agreement by the founder(s) and their decision shall be deemed a final and settled matter.

Section 15. The terminology used in these Articles of Agreement and Members agreements is used solely for clarification of the various usages for Private Members Agreements under universal contract law by and between free, spiritually free men and women, creations of nature and Natures God, whose lives and rights derive from God Almighty and unique Covenant of the man and/or woman with the Creator.

Article II Structure of Lion Roaring PMA

Lion Roaring PMA shall have the following structure of operation:

- The Office of Christ functions as the Advisory Board in providing direction, coaching and guidance for the Lion Roaring Governing Board and the Founders. This Office will be governed by Godly men and women who have kingship and/or priesthood anointing and who receive direction from the Lord Jesus in the areas of five-fold ministries. Through this office, the Governing Board Members and the Founders will ensure that Lion Roaring PMA's mission and vision will be executed and implemented according to God's will to establish God's kingdom with heavenly attributes and following God's supreme law.
- The Governing Board Members function as a team in the Lion Roaring PMA to provide leadership and oversight for day-to-day operations of Lion Roaring PMA. Each Governing Board Member contributes to the Lion Roaring's mission and vision based on each one's anointing, unique skills, calls, and passions for the Lord Jesus. Each member serves as team builder and leader by having the heavenly attributes for both the Lion Roaring Innovation Center and Lion Roaring Education Center.
- Lystia Santosa and Daud Santosa respectively are the founders of Lion Roaring PMA. Lystia Santosa is responsible for all operations of the Agreement, including Members and Members agreements, as well as any disputes which may arise between Members of this Private Members Agreement. The Founder(s), Office of Christ and the Governing Board Members shall automatically be Members of the Lion Roaring Private Members Agreement. The Founder(s)has/ have the power and responsibility to select Members to provide the products and services listed above as provided by the Private Members Agreement. All decisions for the Lion Roaring Private Members Agreement are made and accepted as final by the founder(s), Lystia Santosa and Daud Santosa. All decisions shall remain in the private. All decisions made by Lystia Santosa and Daud Santosa will be considered final and settled as expressed.

Lion Roaring Private Members Agreement shall terminate upon the death of both co-founders; unless prior to this time the founder(s) has named a successor.

Article III - Disputes

Disputes are handled by the founder(s), Lystia Santosa and Daud Santosa, in a timely manner and are not subject to outside litigation as all Members and founder(s) are protected by the united States constitutional and Maryland constitutional right to Member Agreement and contract with one another. All decisions regarding a dispute, complaint, redress for remedy or requests will be made in the private by Lystia Santosa and Daud Santosa. All decisions made by Lystia Santosa and Daud Santosa will be settled as final.

"No state shall...pass any...Law impairing the Obligation of Member Agreements..." united States Constitution Article I, Section 9 Clause 3.

No bill of attainder, ex post facto law, or law impairing the obligation of contracts shall ever be passed. Maryland constitution Article I Section 21

Disputes shall be handled according to biblical principles laid out in Matthew 18: 15-16. Moreover, if thy brother trespass against thee, go and tell him his fault between thee and him alone; if he hear thee, thou hast won thy brother. 16. But if he hear thee not, take yet with thee one or two, that by the mouth of two or three witnesses, every word may be confirmed. And in 1 Corinthians 6: 1-2. Dare any of you, having a matter against another, go to law before the unjust, and not before the saints? Do ye not know that the saints shall judge the world? and if the world shall be judged by you, are ye unworthy to judge the smallest matters? If biblical agreement cannot be reached, the Governing Boards are the second tier to be notified and resolve the disputes. However, if the disputes are still not resolved by the Governing Boards, the Office of Christ as the Advisory Board Members will be consulted for resolution. The ultimate resolution shall be determined by Lystia Santosa, Founder of Lion Roaring PMA and Daud Santosa Co-Founder of Lion Roaring PMA. Final resolution shall be held with what the Lystia Santosa and Daud Santosa, Founder(s), to determine and shall be considered a settled matter of fact.

Article IV - Sovereignty In The Private

Lion Roaring PMA shall operate in the private by free tax-exempt sovereigns of the state of Maryland; declared as free people and settled as a final matter by the paperwork recorded in Guilford County North Carolina Recorder's Office by Jeff L Thigpen as the following recorded documents:

Founder(s) of Lion Roaring PMA declare their sovereignty to do business in the private exempt from all STATE and FEDERAL; state and federal codes, statutes, regulations, rules or color of law, commercial laws or any other STATE, FEDERAL, state and federal rules, regulations, laws, statutes or codes that do not adhere to the limited powers granted to government under the original constitution and the original bill of rights.

Article V - Meetings

Regular meetings of the board Members shall be held on a bi-annual basis or as deemed necessary by board Members to discuss business operations. An email shall be provided to all Members to allow for suggestions as well as feedback on the operations of the Agreement. Periodic open-door or online platform meetings

shall be held for Members either in person or via online meeting groups for the founder(s) to share information and updates as determined by the founder(s).

Article VI - Members

- 1. People, who believe in the Trinity of God and Jesus Christ as our Savior desiring to partake in our training, coaching, mentoring or to receive other goods or services provided need only autograph our Member Agreement and agree to uphold honor and integrity while on the premises and associating with other Members. Dues are paid yearly. Dues are \$20 and includes one half hour of coaching. Members names will be entered into our private non shared database and ID <u>may</u> be asked for if need be. As ID we accept passports or any biblical identification such as entries of birth in the family bible or records from hospitals, birthing specialist, churches, or baptism. We are in the private de jure therefore we do not accept any public corporate ids. We do not accept any driver's license or social security card. Professional license or permits as a form of id. We do honor and respect our military people and will accept a military ID.
- 2. Members Agreement does not entitle a Member to any financial or other interest in the Private Members Agreement or management thereof.
- 3. Any violation of the Members agreement or terms of the Members agreement by any Member of the Private Members Agreement, the founder(s) shall have the right to expel that Member from the Agreement. Members' ability to be part of the Private Members Agreement remains with the founder(s).
- 4. No action shall be taken by any Member that could constitute a clear and present danger of a substantial evil.
- 5. There shall be two forms of Members belonging to the PMA;
 - a. Member workers those Members who contribute their time, labor and expertise to the Agreement in trade or barter for donations, services or goods.
 - b. Members those Members who have autographed a Member's agreement and paid the annual dues to receive products and/or services from the PMA.
- 6. All Members are recognized as sovereign men and women, created in God's own image, a creation of Nature and Nature's God. Each sovereign has the right to exercise his/her free will as intended by God. Each sovereign is encouraged to do their own due diligence. Each sovereign having reviewed the articles of Agreement; completed an application process and autographed a Member's agreement; agrees that they are acting in their Sovereign and their own free will capacity to enter into agreement with other Members and to abide by and follow the guidelines and articles as set up by the Private Members Agreement founder(s) laid out within these Articles of Agreement and the Private Member Agreements. Predicated on the above statements, each Member agrees to their sovereign responsibility for their own education, learning, knowledge and application of the law

and consent to do their own due diligence in any offering of this PMA, to make fully informed decisions on any matter of law PRIOR to entering into a Private Member Agreement to protect each Member's privacy and prevent the unconstitutional and unwarranted application of any public law or jurisdiction to the PMA. This PMA is totally in the private with no lawful jurisdiction outside of those decisions made by the founder(s).

Article VII - Amendments

Section 1. The Governing board reserves the right to amend this parchment at any time and changes must be agreed upon by the founder and co-founder.

Article VII - Construction and Interpretation of These Articles of Agreement

- 1. Any reference within these parchments to the man shall also include the woman and any reference to one people may include many people.
- 2. This Private Members Agreement shall be construed and interpreted in the private and all decisions or disputes will be final as settled by the founder(s).

Article VIII - Termination or Dissolution of the Agreement

 The Agreement will terminate upon the death of the last remaining founder unless designation of a successor for the Founder has been named.

Divine Trust

The founders of Lion Roaring Private Members Agreement view this Private Members Agreement as a divine trust from God. All things biblical are a trust. We recognize God as the executor/grantor of this Private Members Agreement that we have been entrusted. We recognize that we are the trustees of that which God has granted to us. We recognize all Members of our Private Members Agreement as the beneficiaries of what God has entrusted us with. Although this Private Members Agreement is not recorded, created or structured as a trust; it is that which God has divinely entrusted us with that we desire to be the best stewards possible.
